The problem with lantern fly infestation was discussed. They are throughout the neighborhood, and it was noted that there is no specific treatment to get rid of them. They will soon go dormant.

Bill Speg reported that a request for 35 Blossom View Ct. was approved for an expanded deck. It doesn't encroach on setback. Walnut trees on common ground behind 74 Pathfinder Ct. were taken out and new perennial plants will be placed in their stead. This was also approved.

Officer reports included the August Treasurer Report by Mike Keefe. We are very solvent and all bills have been paid.

Old Business: Tree planting will be held in the fall at a future date.

New Business: Mowers will continue to be asked to start after 8am.
